### FORM OF TAXABLE COLLECTION ACCOUNT MONTHLY DISTRIBUTION DATE CERTIFICATE

This Monthly Distribution Date Certificate (the “Information Form”) is being provided with respect to the Kentucky Higher Education Student Loan Corporation Student Loan Backed Notes, Series 2019-1 (the “Corporation” and the “Notes”) pursuant to Section 5.03(c) of the Indenture of Trust dated as of August 1, 2019 by and between the Corporation and The Bank of New York Mellon Trust Company, N.A., as Trustee (the “Indenture”). All capitalized terms used in this Information Form and not otherwise defined shall have the same meanings as assigned to such terms in the Indenture.

The Corporation certifies to information provided herein in reliance upon information that has been received by it from the Trustee as to Notes Outstanding, Indenture Fund balances and Trustee’s Fees with respect hereto and from the Calculation Agent as to the Series 2019-1-1-A Interest Distribution Amount, the Series 2019-1-2-A Interest Distribution Amount and Continuing Covenant Agreement Costs.

Pursuant to this Certificate, the Corporation hereby directs the Trustee to make the deposits and distributions specified in Section 5.03(c)(I) of the Indenture to the Persons or to the account specified below by 3:00 p.m. (New York City time) on March 1, 2023 (the “Monthly Distribution Date”), to the extent of (a) the amount of Available Funds received during the immediately preceding Collection Period in the Taxable Collection Account (or, if necessary, other Available Funds on deposit in the Taxable Collection Account as provided in Section 5.03(c)(I) of the Indenture), (b) any amount transferred from the Department Rebate Fund pursuant to Section 5.05 of the Indenture, (c) any amount transferred from the Reserve Fund pursuant to Section 5.04 of the Indenture and (d) any amount transferred from the Tax-Exempt Collection Account pursuant to Section 5.03(c)(II) of the Indenture. In reliance upon this Certificate, the Trustee shall make the following deposits and distributions, in the following order or priority, to the Persons or to the account specified below by 3:00 p.m. (New York City time) on the Monthly Distribution Date listed below.




