

NOTICE OF PUBLIC HEARING

NOTICE OF PUBLIC HEARING AND OPPORTUNITY TO BE HEARD REGARDING PROPOSED TAX-EXEMPT BOND ISSUANCE BY THE KENTUCKY HIGHER EDUCATION STUDENT LOAN CORPORATION FOR THE PURPOSES OF FINANCING OR REFINANCING EDUCATION LOANS.

The Kentucky Higher Education Student Loan Corporation (“KHESLC”) proposes to issue up to \$178,945,000 in aggregate principal amount of its student loan revenue bonds (the “Proposed Tax-Exempt Bonds”) pursuant to a plan of financing in accordance with Section 144(b) of the Internal Revenue Code of 1986, as amended (the “Code”). The Proposed Tax-Exempt Bonds are expected to be issued, subject to receipt of all required Commonwealth approvals, in one or more series under one or more existing or new indentures of trust to fund some or all of: (i) certain loans originated under the KHESLC Advantage Education Loan Program or under the Federal Family Education Loan Program to finance or refinance higher education costs of attendance; (ii) costs of issuing the Proposed Tax-Exempt Bonds; (iii) capitalized interest; and (iv) debt service reserves.

A public hearing is scheduled to be held remotely by conference call at 10:30 a.m. EST (Eastern Standard Time) on March 11, 2025, for the purpose of hearing the views of interested members of the public in relation to authorizing the financing plan or plans described herein. Notice of this public hearing is being published pursuant to Section 147(f) of the Code.
